THE CONSTITUTION (EIGHTY-SIXTH AMENDMENT) ACT, 2002

[12th December, 2002.]

An Act further to amend the Constitution of India.

BE it enacted by Parliament in the Fifty-third Year of the Republic of India as follows:-

1. (1) This Act may be called the Constitution (Eighty-sixth Amendment) Act, 2002.

Short title and commencement.

- (2) It shall come into force on such date as the Central Government may, by notification in the Official Gazette, appoint.
- 2. After article 21 of the Constitution, the following article shall be inserted, Insertion of namely:-

new article 21A.

"21A. The State shall provide free and compulsory education to all children of the age of six to fourteen years in such manner as the State may, by law, determine."

3. For article 45 of the Constitution, the following article shall be substituted, namely:—

Provision for early childhood care and education to children below the age of six years. "45. The State shall endeavour to provide early childhood care and education for all children until they complete the age of six years.".
